I. Collaborative program content:

II. Collaborative conditions:

- Specific activities of the parties shall be determined by mutual agreement. An administrative coordinator can be designated to promote the effective communicational process.
- ii) . Memorandum of understanding(MOU) for bi-lateral acceptance of eligibility qualifications for the candidates in particular program
- iii). Two parties should supply for the exchange personnel invitation letters and other relevant documents.
- iv) The responsible personnel of two parties carry out the periodic discussion and supervision of the cooperation program.
- v). The evaluation reports for each candidate in his or her university will be Submitted
- vi). Tuition fees, practical training fee, hostel fee, food expenses and associated expenses to be informed in advance.

III.Conclusion:

- The MOU is for a period of 5 years and could renewed annually up to five years.
 Upon the expiration of this MOU, its validity is extended for the next 5 (five) years, if none of the Parties declares its termination, 3 (three) months before the expiration of the MOU
- ii). This MOU is made up in English in duplicate, one for each of the Parties.
- iii). Each party keeps this written agreement with the signature of the institutional representatives of the parties.

The MOU is effective after the two parties sign up.
